- 3. Your personal data is processed for the purposes of:
  - organizing and participating in the Podlaskie Economic Forum,
  - administrative and IT support for the event,
  - related to registration at the Podlaskie Economic Forum,
  - pursuing potential claims, damages,
  - sharing data with legally authorised entities.
- 4. We will process personal information you provide during registration, i.e. your name, position, institution, email address, telephone number.
- 5. The legal basis for the processing your personal data is:
  - The Controller's legal obligation to document the activities related to the organization of the Podlaskie Economic Forum (Article 6(1) (c) of GDPR).
  - Your consent authorizing the Controller to use your image in connection with its posting on social media (including Facebook, Instagram, LinkedIn, Twitter),

at forum.investinpodlaskie.pl and other public sharing and dissemination in such a way that you can view it at any time and place (Article 6(1)(a) of GDPR).

- 6. Your personal data stored will be stored on a sever for three months after the end of the Podlaskie Economic Forum. When processing personal data based on your consent, the Administrator will keep the data until you withdraw your consent. After the processing period has expired, the data is permanently deleted.
- 7. The Controller may transfer your personal data to the following third parties:
  - owners of social media platforms: Facebook, Instagram, LinkedIn, Twitter,
  - IT systems and services providers,
  - The entities with which the Controller has cooperation agreements in place to fulfil the Controller's statutory duties,
  - supervisory bodies, state authorities and other third parties where such transfer is necessary for the purposes indicated above and for the fulfilment of the obligations imposed by law.
- 8. You have the right to:
  - Access your personal data, request for rectification, erasure or restriction of its processing,
  - Withdraw your consent at any time, to the extent that it is the basis for the processing of your data. The withdrawal of consent shall not affect the legality of the processing authorized prior to the withdrawal,
  - Transfer yout personal data, i.e. to obtain from the Controller information on personal data being processed, in a structured, widely used machine-readable format, in so far as your data is processed on the basis of consent,
  - File a complaint the President of the Personal Data Protection Office against unlawful processing of personal data.
- Your personal data will not be transferred to third countries or international organizations, other than social media publications such as Facebook, Instagram, LinkedIn, Twitter.
- 10. Your personal data will not be processed in an automated manner, including profiling.
